The meeting will be held under the General Regulations of The Motor Sports Association. (Incorporating the provisions of the International Sporting Code of FIA) these supplementary regulations and any other written instructions that the organising club may issue for the event. The Official Notice Board will be found in the Rally HQ throughout the event.

- ROUTE INFORMATION:**  
Cars will start the stage at 30-second intervals. The event will contain a number of special stages with a overall mileage approximately 50 miles. These stages will be timed to the nearest preceding whole second in accordance with R31.1.3. The stages will take the form of 100% sealed surface roads.

## 8. CLASSES:

The event will consist of 6 classes as follows: -

Class A	up to 1400cc
Class B	1401 to 1600cc
Class C	1601 to 2000cc
Class D	over 2000cc
Class E	over 2000cc Turbo 4x4
Class F	up to 1000cc complying with F1000 championship or K11 Micra Challenge technical regulations

As this event takes place on private property cars trailered to the venue need not be taxed or insured but must have a valid MOT certificate, V5C document and a MSA log book.

**NB. FIA approved Frontal Head Restraints (HANS devices) are Mandatory from 1.1.16**

## 9. ENTRIES

The maximum entry for this event is 70 including reserves, the minimum is 50.

The maximum entry for each class is 40 and the minimum is 5

Should the above minimum figures not be reached the organisers have the right to cancel the event or amalgamate classes as required.

The entry opens on the 1<sup>st</sup> May 2018 and closes on the 20<sup>th</sup> 2018. The entry fee is £260.00, and all entries must be made as follows: -

- i) Card Payment We are now using Stripe to facilitate card payment (Drivers name as reference)
- ii) Electronic Entry Form with cheques posted to the entries secretary as detailed below.
- iii) Electronic Entry Form with electronic Bank Transfer payment (BAC's) To account below

v) Paper Entry Form posted to the entries secretary accompanied by the appropriate fees.

Cheque payment may be in two instalments, the first to the sum of £100.00 as an initial deposit and dated as entry form. The second to be dated 20<sup>th</sup> June 2018 for the balance of the total fees. Cheques should be made payable to "Warrington & District Motor Club".

Entries will be accepted in order of receipt. Entry fees will be refunded in full if withdrawal is notified in writing to the Entries Secretary before the closing date. Entries withdrawn after the closing date will be refunded entirely at the discretion of the organising club. In the event of a cheque being returned by the bank, the entry will be deemed not to have been received. The organisers reserve the right to refuse any entry.

### **Multiple Entries:**

In accordance with D17.1 a vehicle may be entered twice, with two different crew members applicable to each entry.

### **Crew Members under 18 years of age:**

Under new MSA regulations; Parents, Guardians or Guarantors of drivers under 18 years of age are now required to sign on at the start of events to enable their child to participate. By signing on, those parents, guardians and guarantors confirm that they have acquainted themselves with and agree to be legally bound by the MSA's General Regulations and MSA Regulation D13.1.1(c). They also agree to accept the consequences and any associated penalties imposed for not adhering to the General Regulations. Any crew member under 18 years of age signing on without the appropriate parent, guardian or guarantor present will not be allowed to start.

## **12. RESULTS:**

Provisional results will be published as soon as possible after the event as per D26. Any protest must be lodged in accordance with C5 and H35.

## **13. ROUTE CARDS & SIGNING ON:**

Entrants will be supplied with route cards / time cards at signing on; these documents will contain details of special stages and interlinking sections R33.1. (None of these sections use public highways).

## **14. IDENTIFICATION:**

Competitors will be identified by regulation size numbers, in accordance with R6.1.3a which are to be supplied by the competitor or can be purchased from Rally HQ. In addition, decals that may be supplied by the organisers incorporating publicity for the event must be displayed on both front doors of the car H29.1.1. All numbers and decals must be in place prior to scrutineering.

## **15. FUEL:**

The use of FIA Fuel (FIA Appendix J, Article 252, and article 9) will be permitted on this event. Competitors using fuel that does not comply with the MSA definition of 'Pump Fuel' must display orange discs adjacent to their competition number. J5. 13.6

## **16. MARKING & PENALTIES:**

All Marking and Penalties are as detailed in the 2018 MSA General Regulations (Blue Book) except for the following which are modified: -

R24.7 Judges of fact will be appointed to adjudicate on R4.7.2, 24.7.3, 24.7.5, 24.7.6, 24.7.7, 24.7.8, 24.7.9, 24.7.10, 24.8.1, 24.82, 24.83, and R29.3

All named officials will be deemed judges of fact; additional names will be displayed on the Official Notice Board.

R25.8 Stages will be run at 30 second intervals, therefore there will be no 30 second warnings given. Full details of the Count down Procedure will be given in the final instructions, and displayed at Rally HQ

R25.9 - Pace notes are not allowed but competitors may add notes to the organiser's stage diagrams. R24.11 may apply

R30.1 Controls and checks will be open 5 minutes before due time of arrival of the first car and close on the direction of the clerk of the course.

R31.2.5 & R31.2.6 - Maximum cumulative lateness between main controls - 5 minutes.

R31.2.5 - Over target time on a road section (service area) by more than 5 minutes - Exclusion from results

R38.1.2 - A specific service area will be set aside for cars and no servicing will be permitted outside that area.

R40.1 To be classified as a finisher, a competitor must complete the course (all special stages) inside their maximum lateness without incurring the penalty of exclusion.

**Punctures** - Competitors who suffer a puncture on the circuit **must immediately pull off the circuit**. They may change the tyre and continue if safe to do so. Any competitor continuing to drive on the race circuit or any grassed area with a punctured tyre where the wheel rim is in contact with the tarmac of the race circuit or grass will be excluded from the results and will be liable for the cost of any damage to the surface of the circuit. For this reason, it is strongly recommended to carry a spare wheel, triangle and suitable equipment to complete a wheel change on any terrain. This should be secured in position before scrutineering.

Any competitor who persistently '**corner cuts**' resulting in damage to the grass will suffer the penalty of exclusion.

**Judges of Fact will be appointed for both the above.**

## **17. MODIFICATIONS TO THE GENERAL REGULATIONS**

All other General regulations of the MSA apply as written except for the following, which are modified, or your attention is drawn to in particular.

**FUEL** - The use of FIA Fuel (FIA Appendix J, Article 252, and article 9) will be permitted on this event. Competitors using fuel that does not comply with the MSA definition of 'Pump Fuel' must display orange discs adjacent to their competition number. J5. 13.6

**R.5.4.3.** Subject to holding the appropriate licence required, any member of the signed-on crew can drive.

**RED FLAGS** - All stages will operate a RED flag system in accordance with R24.4.5 and will only be used should extreme circumstances warrant the release of emergency vehicles onto a stage.

**R25.6.4** Upon passing a RED Flag displayed by a marshal wearing a marshal's tabard, you must immediately reduce speed and be prepared to stop, at no time must you overtake any safety vehicle that may be encountered on the special stage route. The driver must follow the instructions of any marshal and/or stage safety personnel

**Failure to comply will be penalised at the Clerk of the Courses discretion which maybe Exclusion.**

#### **STAGE PRACTICE EVENT**

Competitors who retire from the event or are excluded for not visiting a Time Control within their permitted lateness will, at the discretion of the Clerk of the Course, be permitted to continue in a Stage Practice event, which will run concurrent with the main event from Stage 2 onwards, provided that:

The crew has not incurred a penalty of exclusion for any reason other than not visiting a Time Control within the time allowed.

It is the same crew in the same car that started the event.

The vehicle has been re-inspected by the event scrutineers.

The decision to allow a crew to continue rests solely with the Clerk of the Course, who may withdraw the competitors' time cards at any subsequent point.

To take advantage of this option, the crew must report their intentions to Rally HQ and arrange for an event scrutineer to re-inspect the vehicle.

With the agreement of the Clerk of the Course, they will then be issued with an appropriate arrival time for the next SSA.

**Crews will retain their existing competition number and may continue in approximately their original running order or any order specified by the Clerk of the Course .**

#### **18. GENERAL INFORMATION**

The organiser's time and mileage will be deemed correct.

Intending competitors who are not members of invited clubs can obtain membership of Warrington & District Motor Club valid until 31<sup>st</sup> January 2019 for £5.00 per competitor.

Final instructions with the same authority as these ASR's will be sent to competitors on the 23rd June 2018.

Any notice signed by the Clerk of the Course's displayed during the event will have the same authority as these ASR'S.

A maximum of 20mph will apply at all times, within the confines of the venue and on all private roads leading to the venue, with the exception of competing cars on a "live stage".

Competitors should make themselves and their service crew fully aware of current Health & Safety Regulations regarding refuelling, carrying fuel etc. It is strongly recommended that all service vehicles carry a suitable fire extinguisher.

There will be no petrol at the venue.

No bonfires may be lit at the venue, see penalties R32.2 (aa).

Generators and Music to be turned off at 23.00 hrs

Competitors and their service crew may camp at the venue on Saturday night. However be warned that any form of speeding, practicing, or unruly behaviour will be penalised by exclusion of the competing crew See R32 (aa) (cc).
